That exposure will focus both on securities capable of providing equity-like returns as well as fixed income securities where the primary attribute is the generation of attractive fixed income streams. Income generation is a secondary consideration.

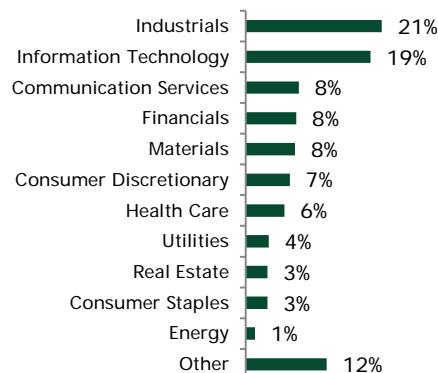

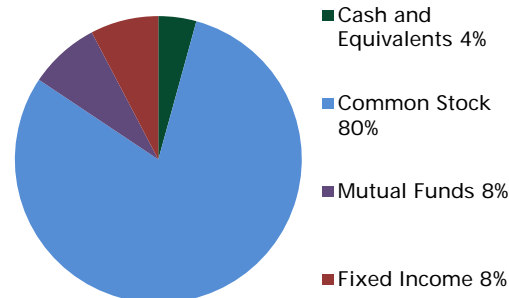

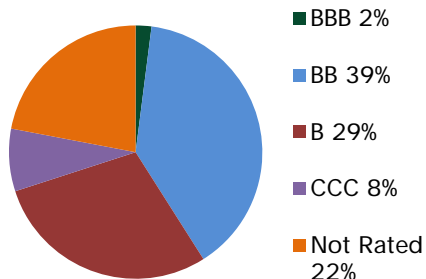

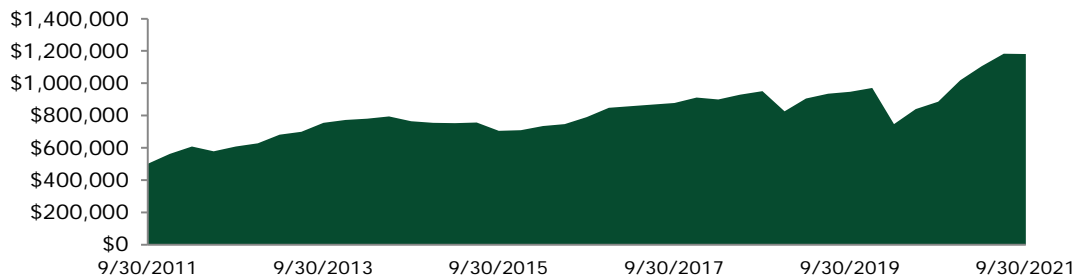
INVESTMENT THESIS

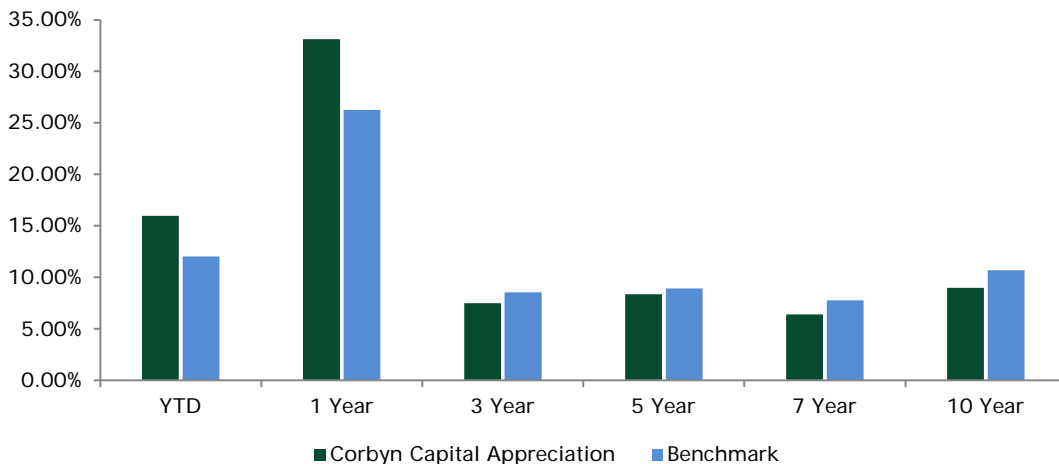

Capital Appreciation Composite: *The objective of this investment strategy is capital appreciation with some income generation. Capital Appreciation accounts are invested primarily in equity securities, but may also include investments in fixed income securities, primarily below investment grade (high yield) corporate bonds. The fixed income securities may be capable of providing capital appreciation, but the primary attribute is the generation of attractive fixed income streams. Key material risks include the risk that stock prices will decline and fixed income securities are subject to interest rate risk that could influence the value of investments. This composite is compared against a custom blended benchmark comprised of 70% Russell 3000 Value / 20% Bloomberg Barclays US High Yield 1-3 Ba Total Return / 10% ICE BAML 3-month T-Bill. The custom benchmark is calculated by weighting the respective index returns on a monthly basis. The Capital Appreciation composite was created July 2016 and inceptioned January 2008.*
