
Focus on short-duration high-yield fixed income securities

- > Our goal is to generate a total return, primarily resulting from current income with the potential for some capital appreciation
- ➤ Bottom-up approach to credit analysis to invest primarily in high-yield bonds, as well as investment grade corporate bonds and convertible bonds
- The strategy aims to achieve total returns while maintaining lower volatility than broader fixed income and equity markets (Returns and Standard Deviation chart below)






Duration to Maturity (Modified Duration): a formula that expresses the measurable change in the value of a security in response to a change in interest rates. Modified duration follows the concept that interest rates and bond prices move in opposite directions. This formula is used to determine the effect that a 100-basis-point (1%) change in interest rates will have on the price of a bond. Duration to Worst: modified duration to the corresponding call date associated with yield to worst. Yield to Worst (YTW): On a corporate bond, the yield to worst is the lowest yield that a buyer can expect among the reasonable alternatives, such as yield to maturity, yield to call, and yield to refunding.

Intermediate Strategic Income Composite: The principal objective of this investment strategy is total return, primarily resulting from current income. To accomplish this objective, we employ a flexible strategy of investing in fixed income securities, primarily below investment grade (high yield) corporate bonds, but may also include convertible bonds and preferred stocks. The expected duration of many securities purchased in the strategy will be longer than that of Strategic Income accounts. Consequently, investors should expect more sensitivity to general market and interest rate moves than the Strategic Income account strategy due to the somewhat longer maturity profile. Fixed income securities are subject to interest rate risk that could influence the value of investments. This composite is compared against the ICE BofA 1-3 Year BB US Cash Pay High Yield Index for all periods presented. Prior to January 2024, this composite was known as Short Duration High Yield Composite. The Intermediate Strategic Income composite was created May 2018 and incepted March 2018.
